P R O C L A M A T I O N

(1) Establishing a Temporary Administration in lieu of State for all the Territory of Palestine in accordance with Articles 9 and 10 of Resolution 56/83 adopted by the General Assembly of the United Nations during the 85th Plenary Meeting on 12 December 2001 and invoking other relevant statutes and elements of international (humanitarian) law such as the four Geneva Conventions of 1949, the Rome Statute of the ICC and the Vienna Convention on the Law of Treaties of 1969, as amended.

Relevant Quote from UN Resolution 56/83 of 12 December 2001

Article 9

Conduct carried out in the absence or default of the official authorities

The conduct of a person or group of persons shall be considered an act of a State under international law if the person or group of persons is in fact exercising elements of the governmental authority in the absence or default of the official authorities and in circumstances such as to call for the exercise of those elements of authority.

Article 10

Conduct of an insurrectional or other movement

2.

The conduct of a movement, insurrectional or other, which succeeds in establishing a new State in part of the territory of a pre-existing State or in a territory under its administration shall be considered an act of the new State under international law.

In view of the following facts

- (2) No force or state exists on Palestinian territory which is able or willing to guarantee the Christian and Muslim Palestinian population even minimal rights, freedoms and legal guarantees in their persons and property universally accorded to persons under international humanitarian laws.
- (3) The continued existence of the "State of Israel" on the territory of Palestine is a problem
 for all the inhabitants of the territory: the native Christian and Muslim Arabs are commonly

- regarded as less than human and treated accordingly by Israel and the immigrant Jewish population, the immigrant Jews on their part are defrauded by their religious and worldly leadership with the help of absurd notions to the effect that they have "god given rights" to Palestine and that their abject crimes against the native Arab population are thus justified.
- (4) All accords, deals, negotiations, compromises between the "State of Israel" (Israel) and Palestinian representatives have consistently been characterized by bad faith on the side of Israel, its representatives and its allies. Accords and the results of negotiations held in bad faith by Israel and its allies have consistently been foisted upon the Palestinian side by governments which are allied with the Israeli side and which are controlled by Zionist elements, notably the United Stated of America, Great Britain, Germany, France, more recently the European Union, as well as others.
- (5) There is currently no organization or instance with the legal ability to represent Palestinian interests before the international community, and there is certainly no legal body authorized to renounce any of the collective and individual rights and property of the Palestinian people. The mandate of the current Palestinian Authority (PA) under Mahmoud Abbas expired on date 8 January 2009 and has not been renewed by elections or referendum as required by law. The Palestinian Parliament has been inactive since years because many of its members have been incarcerated or driven underground by the Zionist occupation. Both an active Parliament and a government (PA) elected by popular referendum would be required at minimum to represent Palestinian interests.
- (6) The PA under Mahmoud Abbas represents Zionist interests and acts against Palestinian interests and national aspirations. It derives its power from funds and military support given mainly by the USA and EU, not from popular consent under Palestinian laws. The PA is dependent in all its actions on the veto of Zionist interests. All obligations incurred by the PA in the name of the Palestinian nation are thus null and void, they constitute treason and fraud.

Rejecting

- (7) the Balfour Declaration of 1917 as an illegal and illegitimate deal among criminals
 regarding plunder to be procured together in the future.
- (8) the "Declaration of the Establishment of the State of Israel" on Palestinian soil of 14 May

- 1948 as illegitimate and lacking legal fundament.
- (9) all treaties, accords, compromises or other deals made by Palestinian representatives with representatives of the "State of Israel", or others representing Zionist interests, as void on the grounds of Article 49 ("Fraud") of the "Vienna Treaty on the Law of Conventions" and force majeure. This refers to the "Madrid Conference", "Oslo Accords", "Oslo II Accords", "Hebron Protocol", "Wye River", "Sharm el-Sheikh Memoranda", "2000 Camp David Summit", "Taba Summit", "Road Map", "Annapolis Conference" and any other known or unknown treaties, agreements or accords made by the PA or any other body in the name of the Palestinian people with the Israeli side.
- (10) the equivocal notion and unsubstantiated claims propagated by Zionist propaganda to the effect that the Jews of the world have claim or entitlement to Palestinian soil.
- (11) UN Resolution 181 of 29 November 1947 as an illegitimate and criminal expression of European colonialism which lacks legal grounds.

Exhorting the UN General Assembly to recognize above mentioned well-known facts and to

- (12) revoke and void UN Resolution 181 of 29 November 1947 and all other UN Resolutions
 partitioning Palestine or recognizing the shameless Zionist claims to the ancestral home of
 the Palestinian people.
- (13) revoke diplomatic recognition of the "State of Israel" and to cancel its membership in all UN institutions on the grounds that the totality of the behavior of its representatives, troops and population in word and deed makes it "hostis humani generis" and thus incompatible with a membership in the UN, and to recommend such a step to all its member nations.
- (14) command the security personnel at all UN premises to arrest all Israeli personnel, especially RON PROSOR, under accusations of complicity in crimes under Chapters 6 to 8 of the Rome Statute of the International Criminal Court of The Hague organized and perpetrated by them or under their command against the Palestinian people, and to transfer all so arrested personnel to The Hague for trial. All such individuals have personally benefited from the campaign of genocide, ethnic cleansing and plunder against Palestinians and their property of the "State of Israel".
- (15) recommend to its members to revoke diplomatic recognition to the "State of Israel"

and to freeze all its assets as well as assets of its representatives in any jurisdiction and hold such goods and assets in escrow and at disposal of a political representation of all Palestinians to be constituted in popular referendum. All such assets are herewith claimed as reparations for grave crimes perpetrated against the Palestinian nation.

- (16) This proclamation is done for all Palestinian Arabs (collectively "Palestinians") living in the West Bank, the occupied territories illegally claimed by the "State of Israel" and other Zionist institutions, the Gaza Strip, and in all other jurisdictions and territories around the world under whatever any status. Palestinians are all Arabs of Christian or Muslim faith who can convincingly claim that they or their ancestors originate from Palestine or that they are the descendants of Palestinians forced to flee due to the Zionist occupation, before or after the Nakba of 1948.
- (17) Palestine is the territory a) to the south of the southern border of Lebanon (tentatively the "UN 2000 Blue Line") between the Mediterranean Sea and the intersection with the "1949 Israeli-Syrian Armistice Line"; b) to the west of the "1949 Israeli-Syrian Armistice Line"; c) to the west of the western border of Jordan between its intersection with the "1949 Israeli-Syrian Armistice Line" and the Red Sea; d) north-east of the Sinai border of Egypt between the Red Sea at Ras El-Masri and the Mediterranean Sea at Taba/Rafah. Any outstanding border issues with neighboring countries shall be settled on amiable terms as soon as possible.
- (18) The Golan Heights territories east of the "1949 Israeli-Syrian Armistice Line" are generally accepted as belonging to Syria and in the case of the "Shebaa Farms", to Lebanon. The General Assembly is requested to cause the end of the occupation of these territories by foreign military forces and cause them to be returned to Syria and Lebanon, respectively.
- (19) The UN General Assembly, the UN Security Council and other appropriate organizations of international law are requested to a) immediately end all activity of the "Middle East Quartet" due to lack of purpose; b) commission and deploy for a limited time an appropriately sized military contingent to protect the Arab population of Palestine from pogroms by the resident Jewish population, to disarm all Zionist military or para-military forces and civilians, to protect the

Palestinian Arabs from further plunder and genocidal efforts by the Israelis. Such efforts shall be undertaken in consultation with representatives of the Palestinian nation elected properly and by free and popular will.

(20) The UN General Assembly is requested to instruct all its members to assist in winding up the "State of Israel", repatriating the Jewish immigrants and their descendants to their home countries to be determined by the precept of "ius sanguini", to cause the discovery and freezing all assets of the "State of Israel" or its representatives or their relatives, the "Palestinian Authority" or its representatives or their relatives, held in their own name or in the name of the "Palestinian Authority", "State of Israel" or any organization or sub-units of said entities or under any other name, until such assets can be turned over to a legitimately constituted political representation of all the Palestinian people. All such assets are herewith claimed as restitution and reparations for the grave crimes perpetrated against the Palestinian nation during more than 6 decades.
